

Thermo Products, LLC. Warranty (Limited) Spirit Gas Furnace

Ten-Year Parts Limited Lifetime Heat Exchanger Spirit Gas Models TG9S*and TP9C* Series

Thermo Products, LLC, a Delaware corporation, hereby warrants the Spirit gas warm air furnace models TG9S* and TP9C* to be free from defects in material and workmanship. The warranty is extended to the original owner(s) whose name(s) appear on the Warranty Registration submitted to Thermo Products, LLC. If registered online within ninety (90) days after date of installation, the registered Limited Warranty period for Parts is ten (10) years. If not registered within ninety (90) days after date of installation, the Base Limited Warranty period is effective and is five (5) years on Parts. The Heat Exchanger warranty is Limited Lifetime for residential applications and 10 years for commercial applications. If not registered within ninety (90) days after date of installation, the Base Limited Warranty period is effective and is five (5) years on Parts and 20 years on the primary and secondary heat exchangers.

PARTS WARRANTY: During the first 60 months after installation, all parts of the furnace are warranted with the exception of maintenance items which require periodic replacement (i.e. filters, orifices, etc.). The owner may arrange with the original installing contractor or any other qualified contractor of the owner's choice to replace a defective part. Any labor costs involved in furnace diagnosis, service or the removal and replacement of a defective part are the responsibility of the owner. Warranted replacement parts will be shipped with instructions to the contractor on disposition of the defective part. Any transportation costs associated with the replacement of warranted parts or the heat exchanger are the responsibility of the owner. For those homeowners who registered the warranty online within 90 days of installation, this coverage is extended to a 10-years Parts Warranty and is extended to the original owner only. Beyond this warranty period, only the furnace heat exchanger is covered.

HEAT EXCHANGER WARRANTY: The primary and secondary heat exchanger carries a 20-year Limited Lifetime Warranty. If at any time during the warranty period the heat exchanger becomes defective, Thermo Products, LLC will provide at its option either a replacement heat exchanger or the necessary repair parts on a no charge basis. Any labor costs involved in the diagnosis, repair or the removal and replacement of a heat exchanger are the responsibility of the owner. The owner may arrange with any qualified HVAC contractor for the necessary labor. Any transportation costs associated with the replacement of the complete heat exchanger or the repair parts are the responsibility of the owner. If Thermo Products, LLC requests the return of the defective heat exchanger, it must be returned by prepaid transportation at the expense of the owner. For those homeowners who registered the warranty online within 90 days of installation, this coverage is extended to a Limited Lifetime Warranty on the primary and secondary heat exchanger and is extended to the original owner only.

ALL COMMERCIAL APPLICATIONS: A commercial application shall mean any application other than for personal, family, or household use. During the first 12 months after installation, all parts of the furnace are warranted with the exception of maintenance items which require periodic replacement (i.e. filters, belts, nozzles, electrodes, etc.) to the original owner. The owner may arrange with the original installing contractor or any other qualified contractor of the owner's choice to replace a defective part. Any labor costs involved in furnace diagnosis, service or the removal and replacement of a defective part are the responsibility of the owner. Warranted replacement parts will be shipped with instructions to the contractor on disposition of the defective part. Any transportation costs associated with the replacement of warranted parts are the responsibility of the owner. The heat exchanger on a commercial application carries a 10-year Limited Warranty. If at any time during the warranty period the heat exchanger becomes defective, Thermo Products, LLC will provide at its option either a replacement heat exchanger or the necessary repair parts on a no charge basis. Any labor costs involved in the diagnosis, repair or the removal and replacement of a heat exchanger are the responsibility of the owner. The owner may arrange with any qualified HVAC contractor for the necessary labor. Any transportation costs associated with the replacement of the complete heat exchanger or the repair parts are the responsibility of the owner. If Thermo Products, LLC requests the return of the defective heat exchanger, it must be returned by prepaid transportation at the expense of the owner. The Commercial Limited Warranty remains as stated above regardless of whether registered within 90 days or not.

THE CONDITIONS OF THIS WARRANTY ARE:

- A. The owner must submit the warranty registration within ninety (90) days of installation to activate warranty coverage. If the warranty registration is received after the ninety (90) day period, the date of installation will be considered the ninetieth (90th) day after the date the furnace was sold to the contractor.
- B. The furnace must be operated within its rated capacity as indicated on the rating label and fired with the fuel for which it was designed.
- C. The furnace must operate with a duct system designed in accordance with ACCA (Air Conditioning Contractors of America) Manual D (current edition) recommendations and a vent system designed in accordance with current industry venting code(s).
- D. The furnace must be installed, set up and maintained by a qualified technician in accordance with local and state codes and/or Thermo Products, LLC installation and operation instructions. The furnace must have been provided reasonable and necessary maintenance.
- E. Failure caused by any third party product, service, or system connected or used in conjunction with the furnace may void warranty.
- F. Limit controls which are supplied with the furnace and having pre-set maximums must not be modified, altered, or by-passed.
- G. The furnace must not be modified and/or operated in any manner other than its design configuration.
- H. No air conditioning or heat pump coil may be installed on the return air side of the furnace.
- I. The furnace must remain at its original installation address.
- J. Thermo Products, LLC. shall not be responsible for any failure due to any acts of God including but not limited to fire, water, storms, lightning, power surges, earthquakes, theft or riots.
- K. Thermo Products, LLC reserves the right, at its sole discretion, to provide a replacement unit in the place of repair parts, in which case the warranty period for the replacement unit is limited to the remainder of the original warranty period.
- L. Damages resulting from freezing of condenser water or condensate will void this warranty.
- M. This warranty does not apply to any unit sold over the Internet, by telephone or other electronic means unless the dealer that buys or sells a unit over the Internet, by telephone or other electronic means also installs the unit.

FAILURE TO COMPLY WITH ANY OF ABOVE CONDITIONS WILL VOID ANY AND ALL WARRANTIES LISTED ABOVE. THIS WARRANTY EXPRESSLY SUPERSEDES ALL OTHER WARRANTIES AND OBLIGATIONS OF THERMO PRODUCTS, LLC. NO PERSON HAS AUTHORITY TO ALTER OR MODIFY THE TERMS OF THIS WARRANTY IN ANY MANNER. THERMO PRODUCTS, LLC ASSUMES NO LIABILITY FOR CONSEQUENT DAMAGE OF ANY KIND, AND THE PURCHASER BY ACCEPTANCE OF THIS EQUIPMENT ASSUMES ALL LIABILITY FOR THE CONSEQUENCE OF ITS USE OR MISUSE BY THE PURCHASER, HIS EMPLOYEE, OR OTHERS.
