Manufacturer's Certification Statement
pertaining to the
Tax Payer Relief Act of 2012

Thermo Products LLC is a manufacturer of forced air gas and oil fired furnaces and split system central air conditioning systems under the Trade name of Thermo Pride.

This Manufacturer's Certification Statement is to serve you, the taxpayer, as certification that certain Thermo Pride furnaces and/or air conditioners are eligible for the tax credits identified in The Tax Payer Relief Act of 2012 (25C).

IRS has published tax credits for the installation of Qualified Energy Property for residential heating and cooling equipment placed in service from January 1, 2012 through December 31, 2016.

The IRS requires the manufacturer be identified: Thermo Products LLC, PO Box 217, North Judson, IN 46366,

A taxpayer purchasing a replacement gas or oil furnace with an Annual Fuel Utilization Efficiency (AFUE) rating of 95% or higher can claim a tax credit of \$150. A taxpayer purchasing a replacement gas or oil furnace incorporating an "advanced main air circulating fan" may claim a tax credit of \$50, regardless of the furnace's AFUE rating. An "advanced main air-circulating fan" is a fan whose annual estimated electricity consumption is no more than 2% of the total annual estimated energy use of the furnace (as determined by U.S. Department of Energy efficiency test procedures).

In cases where the new furnace has both an AFUE rating of 95% or higher and incorporates an "advanced main air circulating fan", both tax credits may be claimed (\$200 total).

Furnaces with 95%+ AFUE Models qualify for Tax Credit of \$150:

CHX3-125N, CHX3-75N, CLHS1-075T42N, CLHS1-100T48N, CMC1-50DV3, CMC1-75DV3

Furnaces with "advanced main air circulating fan" Models qualify for Tax Credit of \$50:

Gas -CDX3-100N, CDX3-125N, CDX3-75N, CHX3-100N, CHX3-125N#, CHX3-75N#, CLHS1-075T42N#, CLHS1-100T48N#, CMC1-50DV3#, CMC1-75DV3#

Oil -OD6A072DV5B, OD6A072DV5R, OD6AX072DV5R, OH6FA072DV4B, OH6FA072DV4N, OH6FA072DV4R, OH6FX072DV4R, OH8FA119DV5B, OH8FA119DV5R, OL11-105*DBE-B, OL16-125*DBE-B, OL20-151*DE-B, OL6FA072DV5B, OL6FA072DV5R, OL6RA072DV5B, OL6RA072DV5R, OME-72T36, RHF-ANE, VH8FA119T60, VHF-ABE, VHF-ABT, VHF-ANE

- Qualifies for both AFUE tax credit and "advanced main air circulating fan" tax credit (\$200)
